

**The Norfolk County Council  
(Loddon, High Bungay Road and Leman Grove)  
(Prohibition Of Waiting) Amendment Order 2025**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2), 4(1), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the “Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Loddon, High Bungay Road and Leman Grove) (Prohibition Of Waiting) Amendment Order 2025 and shall come into operation for all purposes on the 3<sup>rd</sup> day of November 2025.
2. The Norfolk County Council (Loddon, Various Roads) (Prohibition of Waiting) Order 2014 (hereinafter referred to as the “2014 Order”) is amended by:
  - a. Deleting Schedule 2 of the 2014 Order in its entirety.
  - b. Deleting Article 3.(1)(ii) of the 2014 Order.
  - c. Deletion and addition of the lengths of road specified in the Schedule to this Order to Schedule 1 of the 2014 Order.
3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.


C395/54 High Bungay Road (West Side)	-	From its junction with the U76503/20 Leman Grove southwards for 74 metres.
	-	From its junction with the U76503/20 Leman Grove northwards for 215 metres.
		From a point 29 metres north of its junction with U7P433 Kings Wood northwards for 40 metres.
C395/54 High Bungay Road (East Side)	-	From its junction with the U76501/10 Davy Place southwards for 140 metres.
	-	From its junction with the U76501/10 Davy Place northwards for 55 metres to its junction with U71241/10 Beech Close.
	-	From its junction with the C203 Kittens Lane southwards for 128 metres.

U71241/10 Beech Close (Both Sides)	-	From its junction with the C395 High Bungay Road eastwards for 11 metres.
U76501/10 Davy Place (Both Sides)	-	from its junction with the C395 High Bungay Road eastwards for 9 metres.
U76503/20 Lemman Grove (Both Sides)	-	From its junction with the C395/54 High Bungay Road westwards for 11 metres.
