

**The Norfolk County Council  
(Mattishall, C200 Dereham Road)  
(30 mph Speed Limit) Order 2025**

The Norfolk County Council in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the “Act”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as The Norfolk County Council (Mattishall, Dereham Road) (30 mph Speed Limit) Order 2025 and shall come into effect on the 2<sup>nd</sup> day of August 2025.
2. No person shall cause or permit any motor vehicle to proceed along the length of the roads specified in the Schedule 2 to this Order at a speed exceeding 30 miles per hour.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The Norfolk County Council (Mattishall, Dereham Road) (30 m.p.h. Speed Limit) Order 2004 (‘the 2004 Order’) is revoked insofar as it refers to length of road set out in Schedule 1 of this Order.
5. The Norfolk County Council (Mattishall, Yaxham Road, Stone Road and Old Hall Road) (40 m.p.h. Speed Limit) Order 2009 is revoked in so far as it relates to the length of road set out in Schedule 1 of this Order.
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule 2 to this Order, that provision of this Order shall prevail.

**SCHEDULE 1**

**In the Parish of Mattishall**

Delete the following reference from the 2004 Order:-

C200 Dereham Road	From a point 75 metres east of the centreline of its junction with the U35139 Old Hall Road to a point 10 metres east of the centreline of its junction with Mill Road.


## SCHEDULE 2

#### 30mph speed limit

C200 Dereham Road	From a point 30 metres west of the centreline of its junction with the U35139 Old Hall Road to a point 10 metres east of the centreline of its junction with Mill Road.
