

**The Norfolk County Council
(Narborough, Various Roads)**

(30 mph and 40 mph Speed Limits) Consolidation and Variation Order 2026

Norfolk County Council in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereafter “the Act”), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as The Norfolk County Council (Narborough, Various Roads) (30 mph and 40 mph Speed Limits) Consolidation and Variation Order 2026 and shall come into effect on the 2nd day of February 2026.
2. No person shall cause or permit any motor vehicle to proceed along the length of the roads specified in the Schedule 1 to this Order at a speed exceeding 30 miles per hour.
3. No person shall cause or permit any motor vehicle to proceed along the length of the roads specified in the Schedule 2 to this Order at a speed exceeding 40 miles per hour.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. The following Orders are hereby revoked:
 - i. The Norfolk County Council (Narborough) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1996; and
 - ii. The Norfolk County Council (Narborough, C74 Pentney Road) (30 m.p.h. Speed Limit) Order 2000
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.

Schedule 1

In the Parish of Narborough

30 mph Speed Limit

Road	Description
U33379 Eastfields	Entire estate consisting of all lengths extending from the northern and southern junctions with the C45 Marham Road
C573 Main Road	From a point 175 metres north of the centre line of the junction with the C74 Pentney Road, south and south-east to a point 20 metres south-east of the centre line of the junction with the U31692 Narford Road
C45 Marham Road (Chalk Lane)	From its junction with the C573 Main Road south-eastwards to a point 225 metres south of its junction with the 3P459 Sandy Road, a distance of 680 metres
C74 Pentney Road	From its junction with the C573 Main Road westwards for a distance of 200 metres
U31077 Old Vicarage Park	Entire estate consisting of all lengths extending from the junction with the U33312 Meadow Road/ Dennys Walk
U33395 Westfields	Entire estate consisting of all lengths extending from the northern and southern junctions with the C45 Marham Road

Schedule 2

In the Parish of Narborough

40 mph Speed Limit

Road	Description
C573 Swaffham Road	From a point 20 metres south-east of the centre line of the junction with the U31692 Narford Road south-eastwards for a distance of 645 metres
