

**The Norfolk County Council
(Ormesby St. Michael and Rollesby, Various Roads)
(30 M.P.H. and 40 M.P.H Speed Limit) Consolidation and Variation Order 2026**

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (the "Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Ormesby St. Michael and Rollesby, Various Roads) (30 m.p.h. and 40 m.p.h Speed Limit) Consolidation and Variation Order 2026 and shall come into effect on the 22nd January 2026.
2. The Norfolk County Council (Ormesby St. Michael and Rollesby) (30 m.p.h. and 40m.p.h. Speed Limits) Order 1997 (hereinafter referred to as the "1997 Order") and The Norfolk County Council (Rollesby, Main Road and Rollesby Gardens) (30 m.p.h. Speed Limit) Order 2010 (hereinafter referred to as the "2010 Order") are hereby revoked.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour along the lengths of road specified in the Schedule 1 to this Order.
4. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour along the lengths of road specified in the Schedule 2 to this Order.
5. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE 1

In the Parish of Rollesby

30 mph Speed Limit

C457 Fleggburgh Road	-	From the centreline of its junction with the A149 to a point 230 metres south-east of its junction with U69336 Heath Road.
U69336 Heath Road	-	From the centreline of its junction with the C457 Fleggburgh Road westwards for 145 metres.
A149 Main Road	-	From a point 50 metres west of the centreline of its junction with U69714 Coronation Avenue south-eastwards for 1122 metres.

U62085 Rectory Close	-	From the centreline of its junction with the C457 Fleggburgh Road eastwards for its entire length
U62160 Rollesby Gardens	-	From the centreline of its junction with the A149 Main Road for its entire length

SCHEDULE 2

In the Parishes of Ormesby St. Michael and Rollesby

40 mph Speed Limit

A149 Main Road	-	From a point 170 metres east of the centreline of its junction with the U69472 Eels Foot Road westwards for 1075 metres.
	-	From a point 100 metres west of the junction with the C457 Fleggburgh Road to a point 50 metres west of the centreline of its junction with the U69714 Coronation Avenue.
