## The Norfolk County Council (Redenhall with Harleston, Various Roads) (Prohibition of Waiting) Amendment Order 2025

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

## 1. Citation and Commencement

This Order may be cited as The Norfolk County Council (Redenhall with Harleston, Various Roads) (Prohibition of Waiting) Amendment Traffic Regulation Order 2025 and shall come into effect for all purposes on the 4<sup>th</sup> day of November 2025.

- The Norfolk County Council (Redenhall with Harleston, Various Roads) (Prohibition of Waiting) Consolidation and Variation Order 2011 (hereinafter called the "2011 Order") is amended as specified in Article 3 of this Order
- The Schedule of the 2011 Order is amended by the deletion and addition of references to C571 London Road, U76279 Love Lane and C571 Redenhall Road as set out in the Schedule to this Order.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
