

ROAD TRAFFIC ACT, 1934.

**The County Council of Norfolk (Built Up Areas)
No. 2 Order, 1939.**

The Norfolk County Council under and by virtue of the powers conferred on them by sub-section (4) of Section 1 of the Road Traffic Act, 1934, and having consulted with the Chief Officer of Police for the County of Norfolk hereby order and direct as follows :—

- (1) The length of road specified in the First Schedule hereto shall be deemed not to be a road in a built up area for the purposes of the said Section 1.
- (2) Every length of road specified in the Second Schedule hereto shall be deemed to be a road in a built up area for the purposes of the said Section 1.
- (3) This Order may be cited as "The County Council of Norfolk (Built up Areas) No. 2 Order, 1939."
- (4) The Interpretation Act, 1889, applies for the purpose of the interpretation of this Order as it applies for the purpose of the interpretation of an Act of Parliament.
