The Norfolk County Council (Swaffham, Various Roads) (20 mph Speed Limit) Consolidation and Variation Order 2025

The Norfolk County Council in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the "Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

- This Order may be cited as The Norfolk County Council (Swaffham, Various Roads) (20 mph Speed Limit) Consolidation and Variation Order 2025 and shall come into effect on the 24th day of November 2025.
- 2. No person shall cause or permit any motor vehicle to proceed along the length of the roads specified in the Schedule to this Order at a speed exceeding 20 miles per hour.
- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 4. The following entry is revoked from the County Council of Norfolk (Built Up Areas) No. 2 Order, 1939:
 - A1065 Commencing at the point of the Street lamp at its junction with Route B.1077 and terminating at a point 18 and one third yards south of this lamp.
- 5. The revocation pursuant to Article 4 is only in relation to the length of road detailed in Article 4 and not the entire order which shall remain in effect
- 6. The Norfolk County Council (Swaffham, Various Roads) (20 mph Speed Limit) Order 2006 and The Norfolk County Council (Swaffham, A1065 London Street/Brandon Road) (20mph Speed Limit) Experimental Traffic Regulation Order 2024 are hereby revoked.
- 7. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule to this Order, that provision of this Order shall prevail.
