

**THE NORFOLK COUNTY COUNCIL  
(GREAT AND LITTLE PLUMSTEAD, BROAD LANE)  
(30 M.P.H. SPEED LIMIT) AMENDMENT ORDER 2020**

The Norfolk County Council in exercise of its powers under Section 84 and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), having given public notice in accordance with sub-section (2) of that section and having consulted the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order may be cited as the Norfolk County Council (Great and Little Plumstead, Broad Lane) (30 m.p.h. Speed Limit) Amendment Order 2020 and shall come into effect on the 13<sup>th</sup> day of July 2020.
2. The Norfolk County Council (Little Plumstead) (30 m.p.h. Speed Limit) Order 2006 (hereinafter referred to as the "2006 Order") is amended by the deletion and addition of the lengths of road as specified in the Schedule to this Order.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour along the length of road specified in the Schedule to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
