THE NORFOLK COUNTY COUNCIL (RACKHEATH)

(30 M.P.H. & 40 M.P.H. SPEED LIMITS) ORDER 1998

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2) and 84(1) and (2) and part III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 1 of this Order at a speed exceeding 30 m.p.h.
2. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 2 of this Order at a speed exceeding 40 m.p.h.
3. The following Order is hereby revoked insofar as it relates to the lengths of road in the schedules to this Order.

"The Norfolk County Council (Rackheath) (30 m.p.h. & 40 m.p.h. Speed Limit) Order 1996" - Schedule 2 only. 2079

4. This Order comes into operation on the 26th day of June 1998 and may be cited as The Norfolk County Council (Rackheath) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1998.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE 2 40

In the Parish of Rackheath

40 m.p.h. Speed Limit

Green Lane East/Broad Lane  
(C258)

- from a point 108 metres south-east of the centre of its junction with Salhouse Road (C283) to its junction with the B1140 Plumstead Road.

Green Lane West (C258)

- from its junction with the A1151 Wroxham Road to a point 18 metres north of the northern kerbline of Newman Road (U57490).

Salhouse Road (C283)

- from a point 108 metres north-east of the centre of its junction with Green Lane East/Green Lane West (C258) to a point 470 metres north-east of the north-eastern boundary of Eva Road.
