THE NORFOLK COUNTY COUNCIL, (WINTERTON-ON-SEA, U69361 BEACH ROAD) (RESTRICTED PARKING ZONE) ORDER 2025

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Winterton-on-Sea, U69361 Beach Road) (Restricted Parking Zone) Order 2025 and shall come into effect on the 13th day of October 2025.

2 In this Order -

Any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment. Where the context otherwise requires the following expressions have the meaning hereby respectively assigned to them.

"Civil Enforcement Officer" has the same meaning as in section 76 of the 2004 Traffic Management Act 2004;

"General Regulations" shall mean The Traffic Signs Regulations and General Directions 2016.

- 3. Save as provided by Article 4 and 5 of this Order, no person shall, except upon the direction of or with the permission of a police constable in uniform or of a Civil Enforcement Officer in uniform, cause or permit any vehicle to wait, load or unload at any time along the U69361 Beach Road from the centreline of its junction with the U69362 King Street, north-eastwards for a distance of 334 metres.
- 4. Nothing in Article 3 of this Order shall prohibit a person to cause or permit any vehicle to wait along the length of road specified in Article 3 of this Order or on the side of road referred to therein for so long as may be necessary to enable a person to board or alight from the vehicle provided these are not excluded by any road markings or signs pursuant to the General Directions.
- 5. Nothing in Article 3 of this Order shall prohibit a person to cause or permit any vehicle to wait along the length of road referred to in Article 3 for so long as may be necessary to enable:
 - (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations
 - i. for fire brigade, police or ambulance purposes;
 - ii. in the service of a local authority or a water authority in pursuance of statutory powers or duties;

- the laying, erection, alteration, repair or cleaning in, or near, the said lengths of road or side of roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in the Digital Economy Act 2017 lawfully kept installed in any position;
- iv. building, industrial or demolition operations;
- v. the removal of any obstruction to traffic;
- vi. the maintenance, improvement or reconstruction of the said length of road or side of road; or
- vii. the provision of a universal postal service as defined in the Postal Services Act 2011;
- viii. to wait when the person in control of the vehicle is required to stop by law, or is obliged to stop in order to avoid an accident or is prevented from proceeding by circumstance outside their control;
- ix. where the vehicle is owned by a funeral director or owner of funeral vehicles, when in use as part of a funeral cortege.
- 6. The Norfolk County Council (Winterton, Various Roads) (Prohibition of Waiting) Consolidation Order 2020 (hereinafter referred to as the "2020 Order") is amended by deleting the following entries from the schedule of that order:
 - a. U69361 Beach Road (North Side) from the midpoint of its junction with the U69362 King Street/King Corner eastwards to its easternmost end.
 - b. U69361 Beach Road (South Side) from its junction with the U69362 King Street/King Corner eastwards to its easternmost end
- 7. In so far as any provision of this Order conflicts with any previous Order relating to the length of road specified in Article 3 of this Order, that provision of this Order shall prevail.
