THE NORFOLK COUNTY COUNCIL (UPWELL AND WELNEY)

(40 M.P.H. SPEED LIMIT) ORDER 2006

The Norfolk County Council in exercise of their powers under Section 84(1) and (2) and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule to this Order at a speed exceeding 40 m.p.h.
2. The following Orders will become revoked on the date of commencement of this Order as follows:-
 - "The Norfolk County Council (Outwell and Upwell)(40 m.p.h. Speed Limits) Order 1993" – insofar as it refers to the Parish of Upwell;
 - "The Norfolk County Council (Upwell, Lakesend)(30 m.p.h. and 40 m.p.;.h. Speed Limits) Order 1995" – its entry for the A1101 Lakesend in Schedule 2 of that Order;
 - "The Norfolk County Council (Upwell Three Holes)(40 m.p.h. and 50 m.p.h. Speed Limits) Order 1997" – in its entirety.
3. This Order comes into operation on the 29th day of September 2006, and may be cited as The Norfolk County Council (Upwell and Welney) (40 m.p.h. Speed Limit) Order 2006.
4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
