Helping the ambulance service by treating people who have had a cardiac arrest if we can reach them before the ambulance can

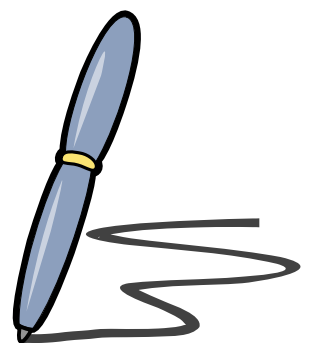

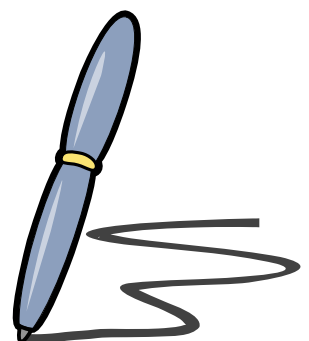

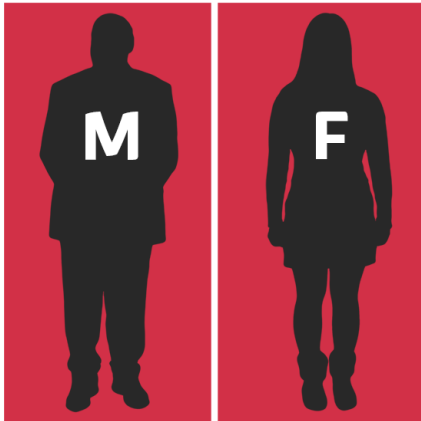
