Overview

The Government wants to see all eight councils in Norfolk replaced with fewer, unitary councils - which are responsible for all services in their area.

This is a unique opportunity to rethink how local public services in Norfolk can best meet future needs and aspirations.

This is a major decision for the Government to make. At Norfolk County Council we don't want to jump to any conclusions - we want to look at all the evidence first before suggesting what approach we think will work best.

Local government reorganisation gives us the opportunity to create effective and high-quality public services for the people of Norfolk. We also strongly believe that the shape of local government should focus on the needs and ambitions of local people, with simpler, more sustainable approaches that provide value for money. So rather than fussing about structures and getting bogged down by bureaucracy we want to focus on the wider picture.

The needs of local people should shape the local government structure, not the other way around.

Why your views matter

Your feedback is crucial in shaping local government to better reflect the needs and priorities of our communities. We will use your feedback to develop a vision for local government in Norfolk and work on more detail over the summer before giving a final proposal to the Government in the autumn.

This is your chance to influence our proposals at an early stage and your opinions matter to us.

What's local government reorganisation all about?

There's a lot going on in the world of local government at the moment.

First off, there's devolution. This is the transfer of powers and funding from national to local government. You may have heard about the proposals for Norfolk and Suffolk to come together to tackle the big issues, like housing, skills and transport under the leadership of an elected mayor.

At the same time the Government wants to change the way that local councils themselves are organised - where county and district councils will be replaced by new unitary authorities, which run all services. This is called local government reorganisation, and it is happening in many places across England.

Currently in Norfolk, some services (like highways and transport, adult social care and children's services) are run by the County Council, while others (like bin collections, planning, and housing) are run by your local borough, district or city council.

We want to hear what's important to you

The Government has asked local areas to come up with proposals for how things could work. At Norfolk County Council we think it's too early to start drawing lines on a map. We need to look at the data and what local government needs to deliver for residents first before focusing in on a preferred option.

We want to hear from you, the people of Norfolk. What are the most pressing issues you face, and how can local government help create the future you deserve? This is where your voice matters.

Although many of us use council services daily, we might not often think about how local government is organised - and that's perfectly okay! Whether you're an expert on local government or just learning about it, we want to hear from everyone. You don't need to answer every question; just let us know what matters most to you.

Services that the County Council is responsible for include:

- Caring for children, including fostering and adoption
- Caring for older people and vulnerable adults
- Looking after our roads, footpaths and cycleways, including filling potholes and gritting roads
- Buses, park and ride services and school transport
- Street lights and traffic signals
- Developing new roads
- The fire and rescue service
- Libraries
- Disposing of waste, including at recycling centres

- Trading Standards
- The registration service for births, marriages and deaths
- Working with businesses to boost jobs and skills
- Museums
- Norfolk Record Office
- Free bus passes for older people and blue badges
- Adult education, including training and apprenticeships
- Public health, including promotion of health checks

- Council tax collection
- Housing
- Planning applications
- Building and development control

- Housing and council tax benefits
- Licensing
- Environmental health
- Business rates
